## Section 4. First-aid measures

### First aid

- Inhalation** : Remove victim to fresh air and keep at rest in a position comfortable for breathing. : Tricresyl phosphate (TCP): TCP (<9% ortho isomer) administered to rats by oral gavage in a one-generation reproduction/developmental toxicology study adversely affected both males and females.
