SECTION 4: First aid measures

4.1 Description of first aid measures

- Eye contact : Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue to rinse for at least 10 minutes. Get medical attention if irritation occurs.
- Inhalation : Remove victim to fresh air and keep at rest in a position comfortable for breathing. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. Get medical attention if adverse health effects persist or are severe. 6.1 Personal precautions, protective equipment and emergency procedures

- For non-emergency personnel** : No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilt material. Put on appropriate personal protective equipment. Avoid breathing vapour or mist. 6.2 Environmental precautions

6.3 Methods and material for containment and cleaning up

7.1 Precautions for safe handling

Benzenamine, N-phenyl-, reaction products with 2,4,4-trimethylpentene (substituted DPA): Results from a supplier's extended one-generation dietary study with 10-week pre-mating administration of substituted DPA included decreased body weight and body weight gains in parental females during gestation and lactation, decreased number of implantation sites and decreased mean litter size.
