**Processing Techniques**

The actual processing condition depends on each machine type, product size, mold design. Generally, melt temperature should be 190-230 deg.C for injection molding and 160-190 deg.C for continuous compression molding. The exceed melt temperature than 250 deg.C might effect organoleptic property.
