Description of necessary first aid measures

Ingestion

Specific hazards arising from the chemical

: Mighly flammable liquid and vapor. Runoff to sewer may create fire or explosion hazard. Methods and materials for containment and cleaning up

Small spill

from the surface by skimming or with suitable absorbents when conditions permit. Seek the advice of a specialist before using dispersants. Warn other shipping. Note: see Section 1 for emergency contact information and Section 13 for waste disposal.

Precautions for safe handling

Protective measures
