## Section 4. First-aid measures

### Description of necessary first aid measures

## Section 5. Firefighting measures

### Personal precautions, protective equipment and emergency procedures

### Methods and material for containment and cleaning up

- Small spill** : Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water-soluble. Alternatively, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.
- Large spill** : Stop leak if without risk. Move containers from spill area. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). Dispose of via a licensed waste disposal contractor. Confine the spill immediately with booms. Remove from the surface by skimming or with suitable absorbents. ### Other information

**Contains** : Tetrapropenyl phenol (TPP). TPP was tested in a rat oral gavage one-generation reproductive toxicity study and a rat dietary two-generation reproductive toxicity study. Results from the one-generation study included reduced ovary weights and changes in male reproductive accessory organs. Results from the two-generation study included prolonged estrous cyclicity, reduced ovary weights, accelerated sexual maturation, decreased mean live litter size, decreased fertility rates, hypospermia, and reduced weights of male reproductive accessory organs. A classification threshold for reproductive effects of 1.5 wt% TPP was derived by the supplier based on the NOAEL (15 mg/kg/day) from the rat dietary two-generation study and was confirmed in supporting studies with other substances containing TPP as an impurity. Base oil severely refined: Not carcinogenic in animal studies. Representative material passes IP-346, Modified Ames test, and/or other screening tests. Dermal and inhalation studies showed minimal effects; lung non-specific infiltration of immune cells, oil deposition and minimal granuloma formation. Not sensitising in test animals.

**Product** : Diesel engine oils: Not carcinogenic in animals tests. Used and unused diesel engine oils did not produce any carcinogenic effects in chronic mouse skin painting studies. Oils that are used in gasoline engines may become hazardous and display the following properties: Carcinogenic in animal tests. Caused mutations in vitro. Possible allergen and photoallergen. Contains polycyclic aromatic compounds (PAC) from combustion products of gasoline and/or thermal degradation products.
