## Section 6. Accidental release measures

### NOTIFICATION PROCEDURES

In the event of a spill or accidental release, notify relevant authorities in accordance with all applicable regulations.

### Personal precautions, protective equipment and emergency procedures

: Synthetic base oils: Not expected to cause significant health effects under conditions of normal use, based on laboratory studies with the same or similar materials. Not mutagenic or genotoxic. Not sensitising in test animals and humans. Benzenamine, N-phenyl-, reaction products with 2,4,4-trimethylpentene (substituted DPA): Results from a supplier's extended one-generation dietary study with 10-week pre-mating administration of substituted DPA included decreased body weight and body weight gains in parental females during gestation and lactation, decreased number of implantation sites and decreased mean litter size.
